

## **DEERHAVEN GENERATING STATION TOUR**

Thank you for requesting a tour of our Deerhaven Generating Station. Before you arrive at the site, please prepare for your tour by reading this and carefully observing our policies.

GRU staff will host your tour of the facility. Your host will provide you with a close-up look at the operations of the plant.

You will be walking on outdoor platforms and climbing steps in the industrial environment of a coal-fired power station. You will see large, rotating machinery in operation, which will be somewhat noisy. It is quite possible that you may get machine oils or coal dust on your clothes.

### **Rules for Deerhaven Guests**

#### **1. GENERAL**

- No weapons, drugs or alcohol of any kind are allowed on the property
- Guests are to stay with the tour group and not wander off into other parts of the facility
- No smoking or the use of smokeless tobacco products while on the tour

#### **2. CLOTHING**

- Sandals and open-toed shoes are **not** allowed. Shoes must have leather uppers and ½” heels. Tennis shoes are acceptable
- Shorts are **not** allowed. Tour guests must wear long pants; capris pants are acceptable for female guests
- Tank tops are **not** allowed
- Hardhats, safety glasses and ear plugs will be provided and must be worn during the walk-around tour

#### **3. HIGH ELEVATIONS/CLOSE SPACES**

- If you have any concerns about high elevations or close confined spaces, please inform your host at the beginning of the tour so arrangements can be made accordingly

#### **4. GROUPS**

- Due to safety concerns, tours of GRU power generation facilities are limited to 9th grade and older
- High school classes **must** provide at least one adult chaperone for every ten students
- Tours are limited to one a month. Group size is limited to 30 people for each tour; however, tours can be staggered to accommodate the tour request e.g. two classes for the same University of Florida class.
- The contact person from the organization requesting a tour must let us know of anyone in the group with mobility issues or a handicap that may prohibit them from using the stairs
- The contact person is responsible for providing GRU with a list of all attendees at least three (3) days prior to the scheduled tour date.
- Every person entering the Deerhaven site will be required to show a picture I.D. before entrance is allowed in order to comply with the plant security and safety procedures.

## **5. SCHEDULING OF TOURS**

- Tours are only scheduled **Monday-Friday during normal business hours**
- Tours outside of normal business hours will be considered on a case-by-case basis and is solely at the discretion of plant management
- Should unforeseen changes arise involving plant operations, GRU may have to cancel the tour. This would only be done in an emergency situation

## **6. TOUR CANCELLATIONS/NO-SHOWS**

- A tour may be postponed, cancelled or rescheduled by the group requesting the tour or by plant management due to unforeseen changes in plant operations. To postpone or cancel a tour, as much notice as possible will be given. We will do our best to reschedule the tour for another date.
- If a tour group does not show up without giving advance notice, the tour will not be rescheduled and may affect future opportunities for the group to schedule tours.
